# The Challenge

- The organization faced litigations with over 150 Do Not Use (DNU) photographers, causing huge drain on the client's time &resources.
- Company needed an efficient way to economically upgrade its Rights and Permissions (R&P) process to prevent litigations along with resource challenges.
- Edition mismatches and exhausted print runs posed problems for text assets.
- They wanted to maximize productivity &minimize costs, while improving accuracy of the R&P process.

**Avoid Discrepancies:** A robust system to track audit trails and manage permissions to avoid litigations and the DNU photographer list.



**Strengthen the Review Process:** Enhance the final sign-off process for accelerated asset discovery and minimal slips associated with R&P.



**Optimize Time-To-Market:** Reduction in the re-research ratio and appropriate asset reuse to ensure faster time-to-market than the competition.
